	§ 1 – Subject of Contract

The subject of this contract is the author's / the authors' work in the form of extended abstracts and ready for press full papers submitted for the proceedings of the *Multikonferenz Wirtschaftsinformatik 2016* which are to be published online and/or in the printed conference proceedings.

§ 2 – Concession of Rights

The author is sole proprietor or the authors are joint exclusive proprietors of all rights to the work. They transfer to the publisher, without any limitation as to country of publication, and for the period to which copyright legally applies, the exclusive right to reproduce and distribute (under the German laws of publishing) the work detailed in § 1 in the proceedings of the *Multikonferenz Wirtschaftsinformatik 2016*, together with any figures contained in the work, for all versions and editions, without limitation as to number of copies, and for all languages. They guarantee that sale or making available of the work will infringe neither the rights nor the claims of any third party, and that he/she/they has/have not exercised the rights in respect of the work in any other way, whether in whole or in part. In particular, the author assigns (the authors assign) the following rights of use over the work to the publisher, without limitation as to time, place or content:

- a) The book rights over the work, that is, the right to reproduce and distribute the work or edited forms of the work in all types of book for all versions and editions, and using all means of distribution, in particular general booksellers, book-related outlets, other retail outlets, book ordering services and similar.
